

Minutes of the meeting to discuss the issues pertaining to Yellowfish in Sterkfontein Dam that were held on Thursday, 19 July 2012 from 09:00 till 13:00 at the Sterkfontein Dam Nature Reserve

1. Welcome and opening

L. Barkhuizen opened the meeting and welcomed all present. The purpose of the meeting was to discuss amongst others the issues raised by E. Dowd in the article in the July 2012 edition of "Stywe Lyne" on "Geelvis word bedreig in Sterkfonteindam". All are aware of the flood of emails that followed after the article was published with people agreeing or disagreeing with the statements made by E. Dowd.

L. Barkhuizen informed the meeting that the Free State Department of Economic Development, Tourism and Environmental Affairs (FS DETEA) would like to see the matters that were raised and that will be raised during the meeting, be addressed as soon as possible. He requested that people be open and frank as to the matters they feel needs to be addressed and that constructive criticism be given. He further requested that all respect each other's opinions and that the meeting focuses on solutions to the problems pertaining to the conservation and protection of Yellowfish in Sterkfontein Dam. At the end of the meeting an action plan must be on the table coupled with a time frame to ensure the meeting is not a waste of time.

L. Barkhuizen proposed that instead of following the Agenda point for point, that a workshop session be done that will eventually lead to the development of an action plan.

Session 1

All present were requested to list all the issues pertaining to the conservation and protection of Yellowfish at Sterkfontein Dam, as well as the threats and current problems been experienced. Before the discussion started, D. Weaver pointed out that all should take note that fly fishers are Nature Conservation's allies and conservation orientated individuals, committed to the conservation and protection of Yellowfish and the environment.

After the listing of the problems/issues and discussions, similar points were grouped together and the final issues, problems or threats that were identified, are:

- (i) The fluctuation of water levels, especially during the spawning season. (ii) Poaching in the streams.
- (iii) Black bass the long term effect.
- (iv) Alien species (Grass carp present in Spioenkop Dam).
- (v) Commercial harvesting of Yellowfish.
- (vi) Walking on banks and through spawning beds / disruption of spawning fish.
- (vii) Bank anglers, boat anglers = "stywe lyne" anglers not aware of the threats to Yellowfish and correct methods of handling Yellowfish.
- Lack of policing/no action from Nature Conservation re selling of fish.
- (ix) Angling competitions.

For the purpose of the discussions and the minutes of the meeting it should be noted that when reference is made to "Yellowfish", it refers to the more abundant Smallmouth Yellowfish, Labeobarbus aeneus that occurs in Sterkfontein Dam, but it does not exclude the Threatened and Protected Largemouth Yellowfish, Labeobarbus kimberleyensis, which seemingly does not occur in large numbers in Sterkfontein Dam.

Angling competitions.	After a lengthy discussion, it was confirmed that this is not a problem at Sterkfontein Dam as the three competitions been held here annually (note TCFF's does not hold a competition, but it is a festival), are dor under strict control measures and according to conservation guidelines. For any angling competition to be held, the organisers need to apply for an official permit, and seemingly none are aware about this. L. Barkhuizen will send out the necessary permit application form that must be completed for permission to present an angling competition. 5. Matters for discussion:

- 5.1 The illegal catching of Yellowfish in the mountain streams
 Was discussed during the development of the action plan.
- 5.2 The disturbance of spawning fish by anglers and fly fishers Was discussed during the development of the action plan.
- 5.3 Wading and walking through spawning beds
 Was discussed during the development of the action plan.
- 5.4 **Proposed control measures and law enforcement actions**A. Schlemmer informed the meeting that a major Law Enforcement Operation in cooperation with the SAPS and SAPS Water Wing will be carried out during the next spawning season at the dam. This was welcomed by all. Understandably the exact date and time for this action cannot be given. Also refer to the action plan for more actions.
- 5.5 Identifying/mapping the spawning areas of Yellowfish in Sterkfontein Dam
 Seemingly the spawning season for Yellowfish at Sterkfontein Dam is from December till
 the end of February, but it is dependent on the water temperature. According to
 D. Weaver spawning usually takes place from 05:00 till ± 09:30 and then again in the late
 afternoon. D. Weaver provided L. Barkhuizen with a map and indicated where the major
 spawning beds of Yellowfish in Sterkfontein Dam are.
- Although discussed during the development of the action plan, there is concern regarding the rapid increase in the numbers of Black bass in Sterkfontein Dam during the past two years and since the first Bass Masters competition were held at the dam two years ago. As Black bass is an alien invasive and aggressive predator, the exact impact on the Yellowfish at this stage is unknown. The presence of this species may have a detrimental effect in the long term on not only the Yellowfish population in Sterkfontein Dam, but all other indigenous species. Through the angling methods for bass, during which treble hooks are used, in some cases Largemouth Yellowfish is caught as a by-catch and these hooks cause severe injuries to the mouth of the Largemouth Yellowfish. It needs to be noted that Sterkfontein Dam is a Yellowfish Sanctuary and that all Black bass that is caught in future, must be killed and not returned to the dam.
- 5.7 The new Free State Nature Conservation Bill (2012) and proposed new regulations pertaining to the protection of Yellowfish

L. Barkhuizen and A. Schlemmer informed the meeting that the new Free State Nature Conservation Bill will probably be promulgated during September 2012. In terms of freshwater fish, the FS DETEA's focus is amongst others on the conservation and protection of the Largemouth Yellowfish, which is listed as a Threatened or Protected species, as well as the more abundant Smallmouth Yellowfish. In terms of the Nature Conservation Regulations that will be promulgated after the new Bill has been passed by the Free State Legislature, specific protection measures have been listed for both of the Yellowfish species.

5.8 The Orange Vaal River Yellowfish Conservation and Management Association (OVRYCMA)

OVRYCMA was established during 1996 by the FS DETEA, the Windknot Fly Fishing Club in Potchefstroom, FOSAF and landowners whose farms and resorts border rivers where Yellowfish occur. The main aim of OVRYCMA is to get as many people as possible involved in the protection and conservation of the two Yellowfish species that occur in the Orange and Vaal River systems. L. Barkhuizen is the current chairperson of OVRYCMA and handed out the information brochure on OVRYCMA as well as the application form for free membership. He invited all present to become a member of OVRYCMA. L. Barkhuizen is also planning to establish an Eastern Free State Chapter of OVRYCMA involving all outfitters, fly fishermen etc. in this part of the Province.

6. New matters

6.1 Sponsors (E. Dowd)

It was noted that there are possible sponsors from various companies that might be willing to sponsor some of the actions e.g. notice boards, posters, patrol boat etc. to assist in the protection and conservation of the Yellowfish at Sterkfontein Dam. D. Weaver mentioned that the possible sponsors need to be approached as soon as possible however J. Joubert mentioned that there is a process in government that needs to be followed before any sponsor may be sought or received by a government department.

6.2 Competitions (D. Weaver)

The possibility of arranging angling competitions and raising funds needed at Sterkfontein Dam was mentioned but then again the money raised cannot be donated to government as a certain process needs to be followed.

7. Summary of discussions and the way forward

The minutes of the meeting and proposed action plan will be forwarded to all interested and affected parties. L. Barkhuizen will investigate the possibility of combining a follow-up session to be held in combination with the next OVRYCMA meeting scheduled to be held in August 2012 near Vereeniging.

8. Date of next meeting

The date of the next meeting will be confirmed by L. Barkhuizen but the *preliminary* date is Thursday, 16 August 2012.

9. Closure

All present were thanked for their inputs and contributions and for taking the time to attend the meeting. The passion from all for the conservation and protection of the Yellowfish, not only in Sterkfontein Dam, is much appreciated and it is sincerely hoped that all matters and issues that were raised will be addressed and solved as soon as possible. The meeting closed at 13:00.
